#### 10:05 – 10:15 Review Steering Committee Meeting Minutes

**Critical Identification Notification System** (Assurance) – Jiles Manning, Todd McNoldy and management staff viewed a video demonstration of the Assurance system and agreed that the system is acceptable for implementation. There was a question from a committee member about the \$5 per user/per year cost, which is a break down of how much it will cost our agency per year to use the Assurance system. **Ex**: For 360 employees it will cost our agency \$1800 a year to subscribe.

**Fire Extinguisher** tags have been replaced in the Labor building and in ORB. The Review Commission needs two new tags and Terri will make the request to Jiles Manning.

**Active Shooter Response** procedures are still being worked out based on three unresolved issues: 1) safety room identification; 2) drill procedures; 3) how training will be administered and tracked. Once resolved and completed, the Active Shooter Response procedure will be included in the perspective Emergency Action Plans.

**OSHR Pedestrian Safety Initiative** created by NCDOT and the City of Raleigh, hosts an online survey where state employees can get involved in identifying hazardous areas, common pedestrian issues, walking routes, crosswalks, etc. The survey is still available with no deadline noted.
