You are hereby ordered to cease or stop operation of all noncomplying devices.

Failure to correct any violations, including non-payment of this and any other outstanding invoices or penalties may result in further penalties not to exceed \$500 per day of operation.

**Right to Contest** – You have the right to contest the violations and penalty amounts contained in this **Notification of Noncompliance and Penalty**. You may contest all the violations and all the penalty amounts, or you may contest only individual violations or individual penalty amounts. You may also contest proposed penalty amounts without contesting the underlying violations.

Stat. §95-69.19(d) and/or 13 N.C.A.C. 13.0304, you file a written petition for a contested case hearing with OAH pursuant to Chapter 150B, Article 3 of the N.C. General Statutes. A copy of such petition must be served on NCDOL General Counsel/Process Agent, NC Department of Labor, 1101 Mail Service Center, Raleigh, North Carolina 27699-1101.
