**Bureau Chief** 

The Chief will not attend the next NBIC meeting in San Diego.

The Chief will attend the Board of Trustees meeting on February 22<sup>nd</sup> and 23<sup>rd</sup> in Miami and a meeting of the American Insurance Association in Washington D.C. on March 28<sup>th</sup> and 29<sup>th</sup>.

The Chief has meetings scheduled with Andy Frazier on January 15<sup>th</sup> to review the Strategic Plan and on March 15<sup>th</sup> to review Work Plans.

Supervisors will discuss final work plans for 2011-2012 and do work planning for 2012-2013 at the same meeting.

The Boiler Safety Bureau will draft and implement a policy for use of the automatic electronic defibrillator(s) AED and Andrew Gunto will renew the CPR/AED training for supervisors and office personnel. It is important to note an AED cannot be used on someone who is:

- A. Under the age of 18
- B. Under 90 lbs. in weight
- C. Conscious
- D. Lying in or near water

The Chief asked supervisors to review the workplace violence brochure with all our employees and stressed we will not tolerate intimidation of field personnel and that field personnel need to report any violence to their supervisors.

## **Assistant Bureau Chief**

An independent audit of our ASME program is scheduled for January 31 and February 1, 2012.

We have been issuing NC specials for fiberglass filter housings at PCS Phosphate. Cliff will audit the fabrication of 2 housings at a non-code shop the week of February 6<sup>th</sup>.

We have made an adjustment to the way we calibrate the QRAE atmospheric testers. Inspectors will bring their QRAE's to the bimonthly meetings where calibrations will be done. Bump tests will be done by the inspector prior to each use and can be done with calibration gas bottles that have exceeded the "best if used by date".

The Bureau has issued two "Cease Operation Orders". One owner has requested an Administrative Hearing to contest our order and the other did not respond. For the first we will be required to attend the hearing and for the second a follow up inspection is required to verify the status of the pressure.

We are going to split Corrective and Preventive actions into separate categories, one for the ASME

Program and one for our various procedures and processes.

There has been an increased focus on getting insurance companies to clear violations on objects they
