

From the Commissioner

The U.S. Bureau of Labor Statistics recently released its national nonfatal injury and illness report for 2017. North Carolina's nonfatal workplace injury and illness rate for private industry declined to a historic low, 2.3 cases per 100 full-time workers, a statistically significant drop from 2.5 in 2016. The nonfatal injury and illness rate is the best gauge for measuring safety and health in the workplace because it accounts for economic growth, an important



factor when you consider the growth our state has experienced. This record-low rate reflects the work of the OSH Division and the many programs and services they administer that help employers and employees improve their workplace safety and health programs.

Communications will launch a podcast called *Inside NC Labor* this Friday, Nov. 30. Thank you to those of you who participated in the poll to select the podcast name. The podcast has been in the works for some time now and its purpose is to inform and educate North Carolina citizens on the role that the Department of Labor plays in state government. HUMAN RESOURCES NEWS FLASH Interim Review Time is Approaching

The 2018-2019 Interim Review task will open in January 2019. This is a great time to access your performance workplan on the system and update your achievements up to this point. We have promoted and encouraged regular check-point or one-on-one meetings between supervisors and employees. Regular informal review meetings are the most effective way to share feedback and track performance and agreed upon goals and expectations as well as demonstrated core values.

The performance management team will share detailed information about the Interim Review Task in an agency-wide email mid-December. We can all start preparing by gathering performance data, documentation, reports and asking a few questions, for example:

Employee questions:

- 1) How would my supervisor describe my performance?
- 2) What are three things that I can't wait to share with my supervisor?
- 3) How will I continue to meet or beat my goals?

Supervisor questions:

- 1) How have I helped the employees who report to me succeed?
- 2) How often have I provided value-added feedback (positive and constructive)?
- 3) What three accomplishments has the employee achieved that I can't wait to share?

There are plenty of ways to effectively prepare for the interim review. The performance management team will provide additional guidance and resources right after the holidays.
