

From the Commissioner

The U.S. Bureau of Labor Statistics has released its annual report covering national-level 2018 nonfatal

occupational injuries and illnesses. North Carolina is one of 12 states and the District of Columbia with rates below the national rate of 2.8 cases per 100 full-time workers.

The rate for private industry in North Carolina in 2018 was statistically unchanged at 2.4 cases per 100 full-time workers, the first time since 2012 that the rate did not decrease. The injury and illness rate is the best barometer for monitoring how we are doing




in terms of safety and health statewide as the rate accounts for growth and reduction in total hours worked in industry. A big thank you to Todd McNoldy and his team for their efforts to collect the survey data for the report.

Interim Review Time is Approaching

The 2019-2020 Interim Review task will open in January 2020. This is a great time to access your performance workplan on the system and update your achievements up to this point. If you have not had your one-on-one progress update meeting, ask for it. Remember that regular informal review meetings are the most effective way to share feedback on actual performance and on demonstration of our core values. Frequent review meetings between the employee and supervisor produces the right balance between working toward achieving goals and delivering superior results.

This is a great time to review your achievements and any opportunity areas and ask for feedback. Your NCVIP performance workplan contains your performance goals and tasks, but it is up to you to work your plan and not wait until the Interim task opens to assess your work up to that point. Now is the best time to start preparing to share your accomplishments so far by gathering performance data, documentation, and reports.

An agency-wide email will be sent before the December holidays to provide specific information on the 2019-2020 Interim Review Task.
