ETTA's Andy Sterlen completes Basic & Advanced Disaster Life Support

Disasters can strike anywhere at any time and may be the result of terrorism, natural disaster, epidemics or any of a number of Homeland Security incidents. The Basic and Advanced Disaster Life Support course was taught in conjunction with Wakemed and the National Disaster Life Support Foundation. It is an intense 15-hour course combining clinical skills for trauma medicine (checking vitals, starting IV catheter's, intubation, splints, backboards and collars, proper use of tourniquet for missing or badly damaged limbs, etc.) and course work in the following:

- Triage in Disasters and Public Health Emergencies
- Health System Surge Capacity for Disasters and Public Health Emergencies
- Community Health Emergency Operations and Response
- Legal and Ethical Issues in Disasters

Participants were graded based on a final written exam and a final practical exercise which included a mass casualty triage and applying clinical skills in a simulated disaster scenario. In addition, this course forces the participants to think outside the box and come up with creative ways for providing Continuity of Operations in a disaster.


