From the Commissioner

One of the biggest jobs we do during the summer months is to make sure employers and workers know how to cope with the season's dangerous temperatures, and much of this is done through our heat stress initiatives, which we started 10 years ago.

As we all work through some of the hottest days of the year, my concern is with those workers across the state who labor outside in the heat. Extreme heat causes more deaths nationally than any other weather-related hazard; each year more than 65,000 people seek medical treatment for extreme heat exposure.

This year, we have partnered with The National Institute for Occupational Safety and Health and OSHA to promote OSHA's Heat Safety Tool, a downloadable app for cell phones. We are encouraging everyone to download it so they can track extreme heat and how it affects our bodies. If you're one of our field workers or a supervisor, please make sure our own workers and yourselves are properly hydrated and monitor signs of heat-related illnesses.

The coming of July also means the start of a new fiscal year. The General Assembly will soon conclude its work for the 2017 long session, but we will continue to monitor the progress of several bills that are relevant to the department. I am pleased that the 2017-2019 budget, adopted by the legislature earlier in June, includes new but modest funding increases to address several key departmental priorities.

And while I wish it could be more, I'm also glad that the General Assembly recognized the hard work of state employees by granting a \$1,000 salary increase and three additional bonus leave days annually.

Finally, as we approach Independence Day, I can say that I am proud to live in a country where we can enjoy the freedom to live, work and worship where we choose. These are freedoms that many have worked and sacrificed for us to have.

As we pause to honor them, I hope that each of you has a safe, fun and memorable Fourth of July.
