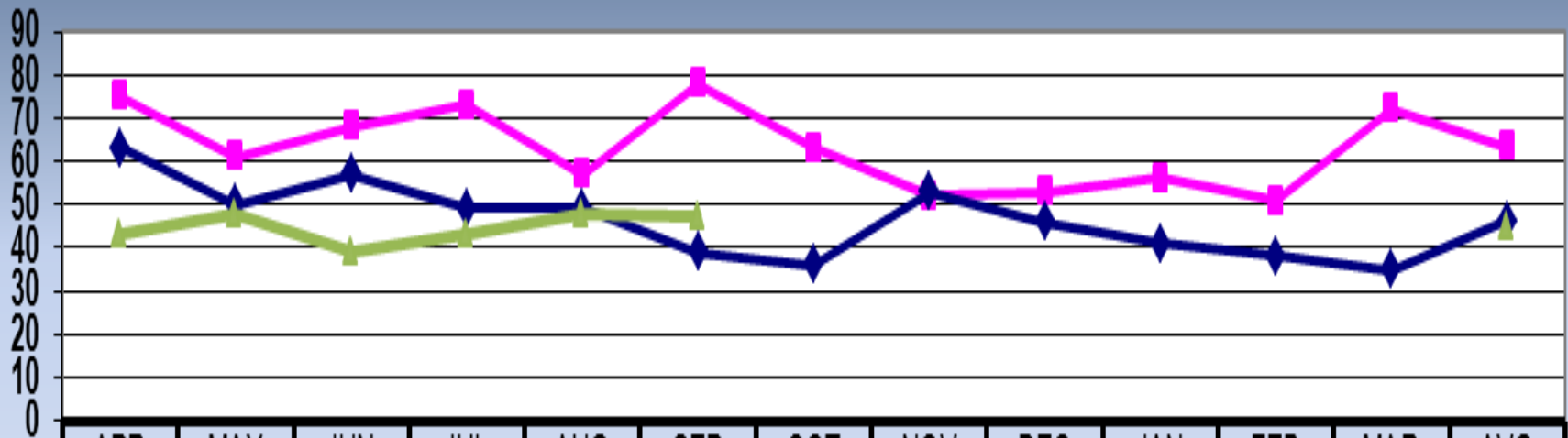

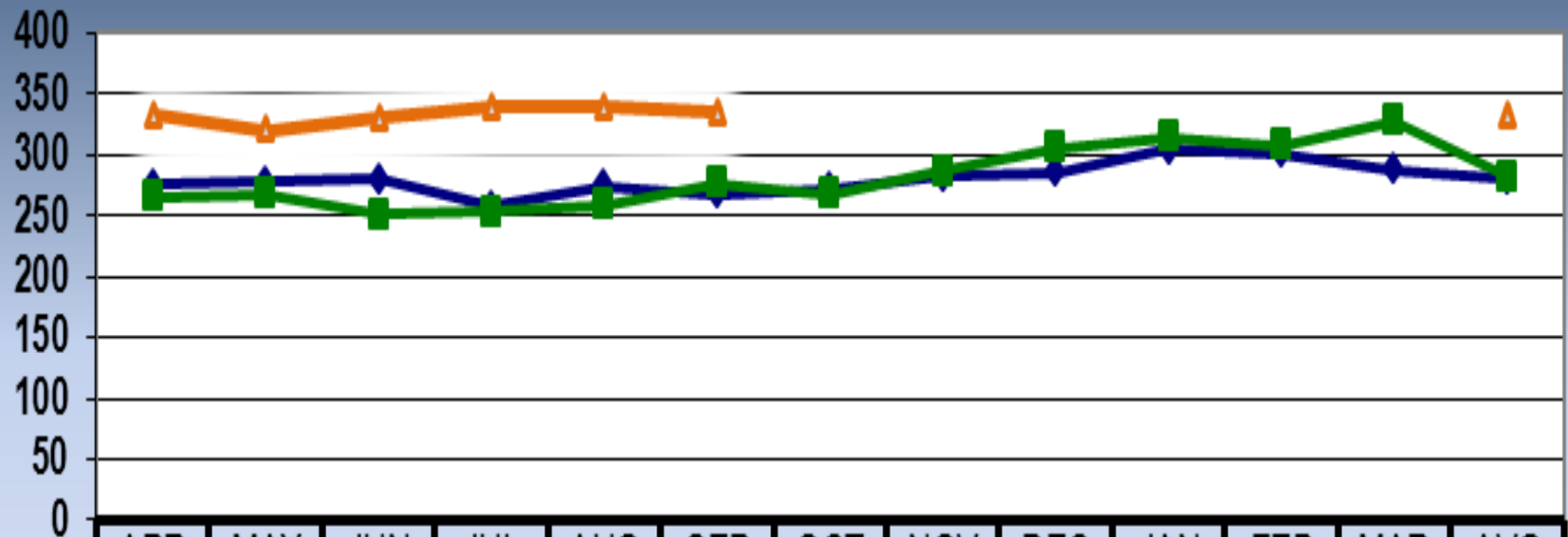

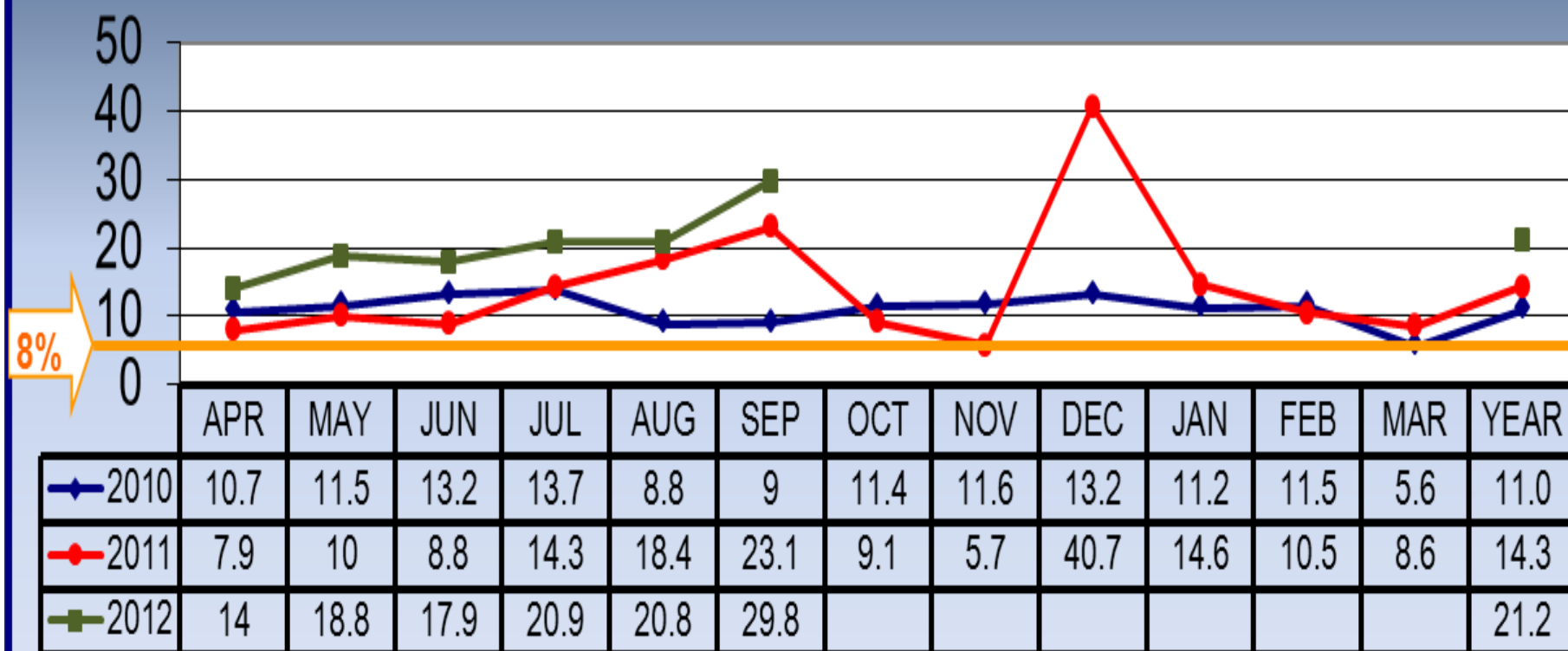

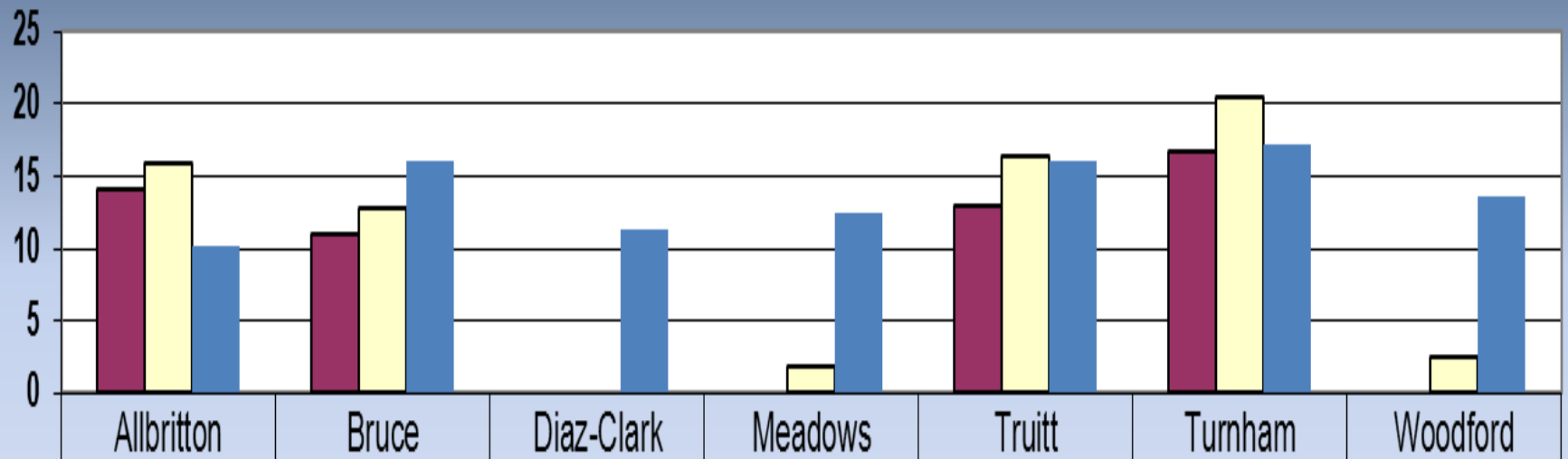

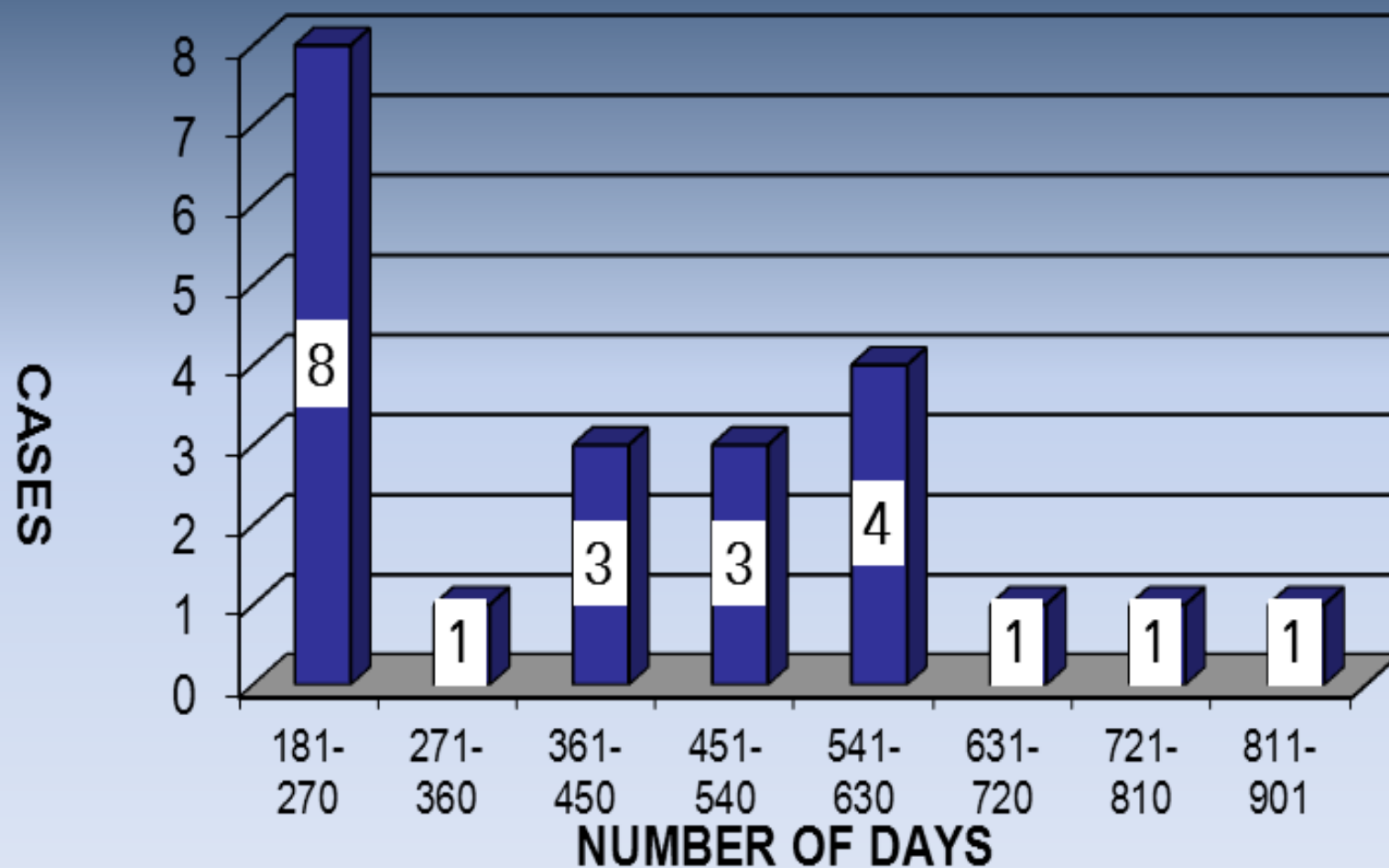
PERCENT OF CASES COMPLETED BY INVESTIGATOR

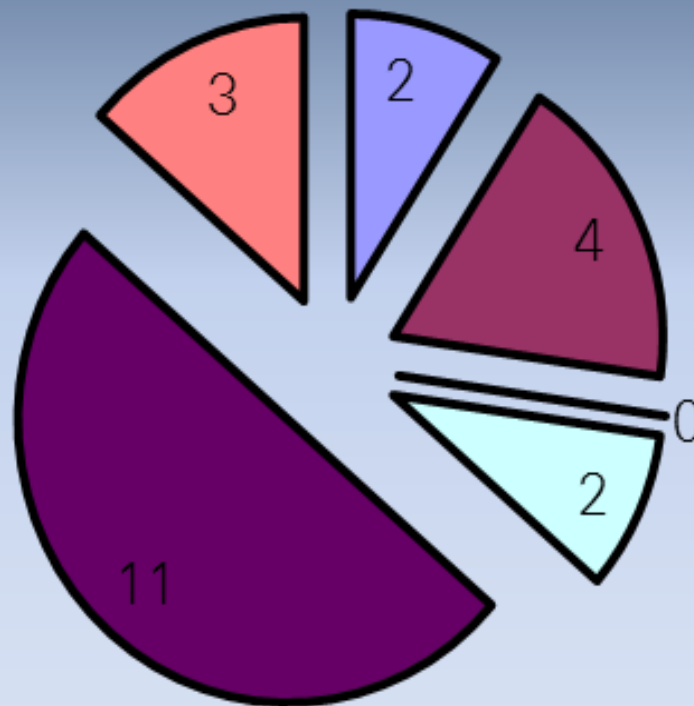

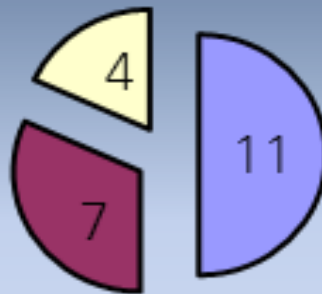

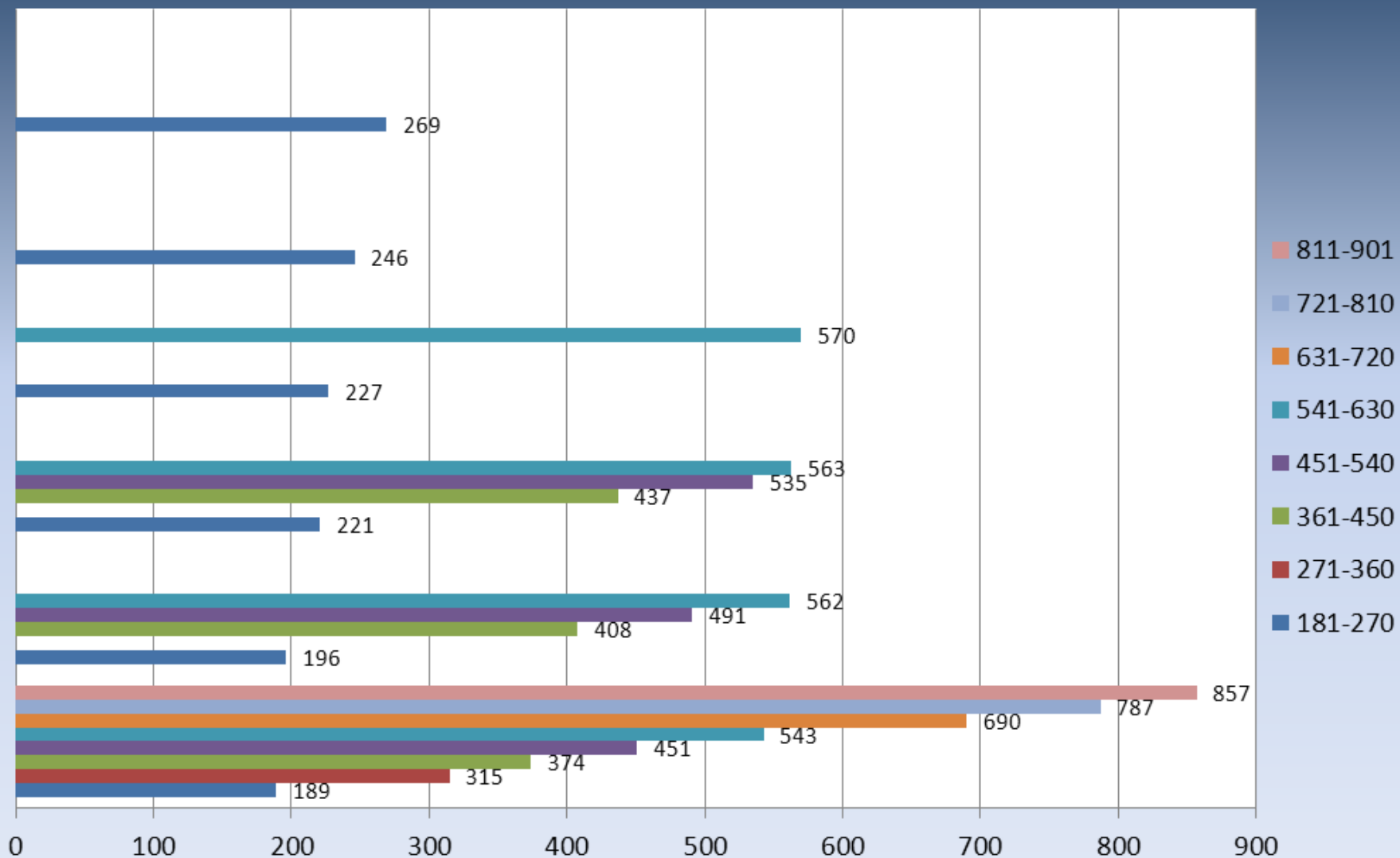
