ETTA offers a variety of safety and health training to the public through leader led classes and webinars. Our courses range from one hour to 30 hours and are offered in both English and Spanish. We independently host many classes through the North Carolina Community College System, and we also offer a Speakers Bureau that allows an employer to request training at its worksite. Trainers are available to address a variety of regulated workplace safety and health topics (typically one- to two-hour presentations). Our training programs address basic safety and health issues and regulatory compliance criteria. Our programs are intended to be a supplement to the site-specific and hands-on training each employer must address for specific OSH standards. Our training programs do not offer a hands-on component. Webinars

30-Hour Courses

We host four 30-hour courses a year—two general industry and two construction industry. We rotate these around the state and focus on large geographic areas. We usually use the community college small business centers or other government facilities. We open all of our courses to the public and require a minimum seating for 50 people (comfortably seated in an environment conducive to adult learning, workshop style).

10-Hour Courses

We host around 16 to 20 10-hour courses a year. These are split between general industry and construction as well as English and Spanish. We manage these like the 30-hour courses, but we are able to reach more remote and smaller locations across the state because the courses are shorter and require fewer resources.
