From the Commissioner

It is hard to believe that another safety awards season has come to an end. The last banquet was held in Mount Airy at the Cross Creek Country Club on June 24. Overall attendance surpassed last year, and at many venues, the rooms were filled to capacity.

The increased participation in the Safety Awards Program is exhilarating and is a real tribute to the teamwork demonstrated by Eursula Joyner, Sandra Allen and the entire ETTA recognition team. It has been an honor for me to be a part of the Safety Awards program for the past 16 years and present participants throughout the state with silver, gold and million hour awards. I look forward to presenting many more of these awards in the years to come!

On another note, the Legislature appears to be wrapping up its business for the short session, and our agency made some gains. Concerning the budget, NCDOL received a much needed \$300,000 one-time credit for information technology needs. While we had hoped for recurring funding, this allotment will buy us one more year of funds to help with the server maintenance and other IT projects. Moving forward, Jennifer Haigwood will work to revisit additional IT needs with the Legislature next year.

In addition, the budget allowed for a 1.5 percent pay raise and a one-time, across-the-board bonus of 0.5 percent for all state employees. While this is not as much as we had hoped for, I'm glad the House and Senate were able to compromise and provide some compensation for all state employees.

The budget also allowed for a pool of money for additional one-time, merit-based bonuses. The distribution and allocation policy of the merit-based pay will be ironed out in the coming weeks and will be distributed appropriately based on performance.

Unfortunately, the budget did eliminate two vacant OSH positions, which came at a time when the OSH Division is struggling to fill positions. I am hopeful that the Salary Adjustment Fund, which is reflected in the June paychecks for many of you, will help with recruitment and retention.

I will be the first to say that all of you are deserving of a salary that actually reflects your contributions to the mission of this department; however, the Legislature had to focus on positions that were severely underfunded based on their true market value. This is the second infusion from the Salary Adjustment Fund to the department in the last three years, and we hope that the Legislature and the Office of State Human Resources will continue to study the competitive value of all of our professionals to ensure that each of you is compensated as fairly as possible.
