## Gold Star Grower Luncheon

The Agricultural Safety and Health Bureau held its 17th Annual Gold Star Grower Luncheon on Feb. 2. The event was held in the Gov. James G. Martin building at the N.C. State Fairgrounds on the opening day of the N.C. Department of Agriculture's Southern Farm Show. More than 170 people attended.

Gold Star growers are those whose housing meets 100 percent of the requirements during the preoccupancy inspection and who have gone beyond the requirements. Double Gold Star growers (who have met the 100 percent threshold for two consecutive years) are eligible to conduct their own housing inspections. The 98 Double Gold Star growers were invited to the luncheon, in addition to 103 Single Gold Star growers.

In 2009, the ASH Bureau created the Ronald Frederick Hudler Workplace Safety Training Award in memory of Ron Hudler. Ron made safety training a priority for his employees. As a part of this training, he periodically set up several training stations that focused on the different types of equipment used on his farm and employees rotated through each of these stations. This type of training is carried on today by his son, Dale. This year's award recipients were Ricky and Trellis Lasley.

- Best New Construction: David Hopkins
