The Mine Safety and Health Administration recently released the injury and illness rates for calendar year 2011 for the minerals industry, which includes all metal and non-metal mines. North Carolina has the fourth lowest incident rate in the nation at 1.85 per 100 full-time workers. This is a drop from 2.44 the previous year and is the lowest rate for North Carolina's mineral industry in five years.

William Gerringer and his team of representatives provide invaluable education, training and technical assistance to miners and contractors and have been instrumental in the reduction of injuries and illnesses at mines, quarries and sand and gravel pits throughout the state. Marcia Page provides the much-needed support behind the scenes for the bureau, so that these dedicated staff members can focus on education and training in the field. Congratulations to all on a job well done.

In August I shifted gears from the safety awards season to fair season and attended the opening ceremony for the Drexel Community Fair. It is always nice to visit with our fair partners across the state. We are waiting on the renewal of two fairs, but once confirmed, we will have a total of 25 fair partners for the 2012 fair season.
