OnBase Electronic Content Management System Goes Live!

On Monday, Aug. 26, our new electronic content management (ECM) system "went live." OnBase, the new system, was officially put into production and FileNet began its official retirement after many years of faithful service.

August saw a flurry of intense activities completed in preparation for this transition: content was migrated from FileNet to OnBase; instructor-led and web-based training sessions were held for OnBase users; the OnBase software was installed on workstations and laptops; and transition planning meetings were held.

Implementation of the new system is in the very early stages, but initial feedback from users has been very favorable. ImageSoft, our ECM vendor, is working closely with our PC Support Team to monitor and support the rollout.

What's next: Bureaus will complete verification that all existing content was successfully migrated from FileNet to OnBase. The PC Support Team will complete installation of the OnBase software for all teleworkers that will use the system. Follow-up OnBase training sessions will be held.

Completing the transition from FileNet to OnBase establishes the foundation for DOL to expand the use of OnBase throughout the organization. The second phase of the project will focus on completing the automation of some key business process workflows.

Thanks to everyone—in the bureaus as well as in the Research and Information Technology Division and at ImageSoft—for working so hard to make this first phase of the project a success.
