From the Commissioner

We started off November with some very good news from the Bureau of Labor Statistics about the state's injury and illness rate for the private sector. The rate for private industry dipped to a historic low 2.9 cases per 100 full-time workers. The rate had been at 3.1 for the previous three years.

North Carolina was one of eight states to see a decline in injury and illness rates from the previous year and was one of 15 states with a rate statistically lower than the national average of 3.4.

The hard-working men and women in the OSH Division deserve much of the credit for reaching this milestone. The low rate supports our premise that providing a combination of compliance, consultation, and education and training coupled with increased partnerships, alliances and increased recognition programs through our Carolina Star Program and SHARP is working.

Lee Peacock recently sent a message to all kicking off our annual Toys for Tots drive in conjunction with the U.S. Marine Corps. Lee Peacock's passion for the annual toy drive started 15 years ago when he started his first drive in the Charlotte office. Since then, the Toys for Tots drive has evolved into a department-wide initiative that we have all grown to love.

Over the years, we have watched the drive expand to include our neighbors at the Department of Justice and State Auditor's offices, and now the Governor's Office has volunteered to partner with us to help support this cause. We are excited to have additional support this year from Gov. McCrory and the first lady and their staff members.

As usual, we will conclude the Toys for Tots Drive on Dec. 12 at the annual Christmas Open House scheduled for 2 p.m. to 3:30 p.m. in the Labor Building. Please stop by to see all the toys if your schedule allows. Knowing the toys will help so many needy families across the state that may otherwise not have experienced toys under the tree on Christmas morning reminds us of the true meaning of Christmas.

I also look forward to celebrating the holidays with many of you in the coming weeks as we continue our Employee Appreciation Program awards with many of the field offices.
