
I am grateful to Univision and Skanska for working with us to continue this campaign and I sincerely hope our construction safety message is resonating throughout the Hispanic community.

Deductions for State Health Plan

Please check your December pay statements in Beacon to make sure your State Health Plan deductions are correct. To check your pay statements, log in to Beacon, click on My Data ESS, then click on My Pay. You will see a link for Pay Statement. If you enrolled in the PPO 80/20 plan or the PPO 85/15 plan and completed the three wellness activities, make sure you see three premium credits on your pay statement. If you are missing any premium credits, or if other information is incorrect, please email Stacey. Thompson@labor.nc.gov and let her know which credits are missing or what information is incorrect. Keep in mind that NCFlex deductions for 2015 plans are not reflected on your December 2014 pay statement. Those deductions will begin in January's payroll.
