From the Commissioner

Some of you may have heard the news about workplace fatalities increasing in North Carolina in 2014. Communications released the fatality figures statewide last week.

The construction industry was the leader in workplace deaths with 19 fatal events followed by manufacturing with nine. Construction fatalities accounted for 43 percent of the 44 workplace fatalities that occurred.

While this is not the best news, we hope that it brings attention to employers and employees of the troubling trend in the construction industry. Other industry data show that many construction accidents are happening within the first 60 to 90 days on the job and in some cases on the first day of work.

This statistic sends a red flag that the workers are not getting the necessary training prior to starting the job. We hope that releasing the news will bring awareness to general contractors and subcontractors throughout the state of the importance of safety training and refresher safety training prior to starting their workers in innately hazardous construction jobs.

Our OSH Division has been proactive: Three construction partnership agreements for major construction projects were recently signed and the number of 10- and 30-hour construction industry awareness courses offered have been increased along with other courses that address the "big four" hazards in construction.

Meanwhile, the construction public service announcements made possible by Builders Mutual, Skanska Building USA and Univision will continue airing on Univision through March of 2015. The PSAs focus on falls, struck-bys and the importance of returning home to loved ones at the end of the work day.

While the fatalities are important to track in order to identify patterns and trends, we believe the injury and illness rate is a much better indicator of how our state is doing in terms of workplace safety and health. The state's injury and illness rate for private industry for 2013 dropped to an all-time low 2.7 per 100 full-time workers. When you look at the big picture of all 50 states, North Carolina is still one of the safest states in which to work.

Keep up the great work.
