The new fiscal year will begin July 1 under a continuing resolution that will keep state government running smoothly in the meantime.

As you may have heard, the Senate and House are proposing cuts to our department of 3.1 percent and 1.6 percent respectively. Our lobbying efforts are geared toward the House position. We will keep you posted on any news that transpires as the House and Senate work to negotiate their differences.

ASH On-the-Farm Training Events

The staff members of the Agricultural Safety and Health Bureau have scheduled three on-the-farm safety training events for this summer. The first took place June 3 at Mark Ross's farm in Williamston in Martin County. The second took place at Fann Farms in Salemburg in Sampson County. The third will take place July 2 at Barham Farm in Wake Forest in Wake County.

The training sessions each have six or seven stations for farmers and farmworkers to work their way through in groups. Other agencies attending the training sessions include the U.S. Department of Labor's Wage and Hour Division, the Equal Employment Opportunity Commission, and DHHS's Office of Rural Health. William Gerringer and Steve Franklin from NCDOL's Mine and Quarry Bureau provided stations with first aid and CPR training. ASH summer intern Regan Buchanan translated the first aid and CPR training for the Spanish-speaking workers.

Other topics have included field sanitation, heat stress, green tobacco sickness, migrant housing regulations, farm machinery (grain auger, forklift, tractor, tobacco harvester and tobacco baler), farm labor contractors, sexual harassment and pesticide safety.
