

From the Commissioner

I am looking forward to attending the first North Carolina Summit on Safety Leadership at the North Carolina Zoo in Asheboro on Friday, March 4. The department joins the N.C. Zoo, the Safety and Health Council of North Carolina, and N.C. State University—Industry Expansion Solutions as sponsors for this event.

The Summit on Safety Leadership is designed to bring together experts in safety and health to share practical and proven guidance, techniques, case studies, and experiences to assist attendees in moving their organization on the journey to safety excellence. Thanks to Wanda Lagoe for helping line up the many speakers, including our own Kevin Beauregard, Marcy Collyer, Reggie Matthews and Carl Hunter.

The summit is also part of the Manager of Environmental Safety and Health (MESH) Program's 20th anniversary celebration that is being celebrated this year. In 1996, the Safety and Health Council created the MESH certificate program in partnership with NCDOL and N.C. State University. Since 1996, nearly 2,000 students have completed the training requirements for the certificate.

The MESH Certificate Program now includes the Advanced MESH Program, the Construction MESH Program, Industrial Hygiene MESH, and MESH-Public Sector. I look forward to seeing many of the MESH Program graduates while at the conference. This program deserves much of the credit for the great strides we have made to reduce our state's injury and illness rate to the all-time low 2.7 per 100 full-time workers.

In addition to the summit, the department will once again co-sponsor the upcoming annual safety and health schools being offered in the eastern and western parts of the state. The safety and health schools provide a platform for addressing current and timely information on occupational safety and health issues. The Eastern Carolina Safety and Health School is scheduled for April 14-15 in New Bern, the Charlotte Regional Safety and Health Conference is scheduled for April 21-22 in Gastonia, and the Hickory Safety and Health School will take place April 27.

As with any successful event or program, there is a lot of coordination and preparation that goes on behind the scenes. I'd like to thank Giles Manning, Laura Crawford, Bill Allen and John Saunders for their work to make these schools available to many employers and employees in various regions of the state.
