## From the Commissioner

With the end of the school year quickly approaching, thousands of teenage workers are seeking summertime employment opportunities and requesting youth employment certificates from the Wage and Hour Bureau of our Labor Standards Section. The purpose of the certificate is to ensure that teens between the ages of 14 and 18 work in safe and healthy environments. Administering the certificates is one of the most important functions the Wage and Hour Bureau performs.

Last year, more than 75,000 youth employment certificates were issued, and most of those were for summer jobs. Requesting a certificate is required by law and some requests may be denied by the bureau in instances where a youth intends to work in an environment that is deemed unsafe. For instance, teens are not permitted to work in manufacturing or mining. Once the certificate is issued, the youth, a parent and the employer are required to sign the certificate to ensure everyone understands what the summer job entails. I want to thank Christine Ryan, Kisha Holmes and their team for doing their part to create awareness of the online availability of the certificates and for ensuring that the certificates are properly administered. There is nothing more important than protecting our teen workers.

Another very important workplace safety initiative is taking place this month. The National Safety Stand-Down, will take place the week of May 8-12. The purpose of the national campaign is to raise awareness and prevent fall hazards in the workplace, particularly in construction. Falls from elevation continue to be a leading cause of death in the construction industry nationally and locally. Seven of last year's construction deaths investigated by the OSH Division, involved a fall from a roof.

I'd like to thank Marcy Collyer and Bob O'Neal in ETTA for spearheading this worthwhile initiative to prevent falls in construction. Events to create awareness will take place throughout the week with various construction companies and Builders Mutual Insurance Co. in Raleigh, Fuquay Varina and Charlotte. Through the department's alliance with Lamar Advertising Co., a billboard, located near 2526 N. Church Street in Rocky Mount, helps promote the campaign.

During last year's Safety Award season, North Carolina workplaces earned almost 3,500 safety awards and I enjoyed presenting each one. As this year's safety award season commences, my thoughts are constantly focused on workplace safety, and on the great work we are doing, in all sections of the department, to ensure that safety does continue to be our number one priority.
