Performance Report

Reviewed Staff Development

One MAQB representative conducted 1-day Explosives Safety class for Boone Fire Marshals – Boone, NC 33 people attended. Two MAQB representatives conducted Part 48 Instructor Fundamentals class in Greensboro, NC on August 2-4 and 10 people were trained as Mine safety and Health Instructors. One MAQB employee attended the National Mine Safety & Health Academy's 40th Anniversary Celebration in Beckley, WV on August 17th along with the State Grant's meeting on the 18th. One MAQB staff employee and three MAQB representatives attended the NC Aggregates Safety & Health meeting in Greensboro, NC on September 13th. One MAQB staff employee & 1 MAQB representative conducted 1-day Explosives Safety class for BRS in Richfield, NC on September 27th and 38 people attended. Also, 1 MAQB staff employee and 1 MAQB representative conducted Mine Safety and Health Law School in Castle Hayne, NC September 27-29th and 34 people attended.

Abandoned Mines

Abandoned mines have been completely removed from the charts and language and are no longer being reported. IT has to remove abandoned mines from the activity report and make all zeros.

Explosives Safety Class

Art – Does Mine and Quarry receive requests for explosives? William – No. Usually, requests are for the construction of subdivisions and are issued by the County Commissioner or Fire Marshall. The issuance of blasting permits is up to them. Usually, the person asking for the permit will take a good picture, document the area and take it to an attorney to ask the County Commissioner of Fire Marshall for the blasting permit.

State Grant's Meeting

2017 State Grant funding looked good with MSHA. Mine & Quarry is waiting for MSHA for notification to submit. Art – CER is good until December 8, 2016. There is a new State Grant form they want everyone to use in November. MSHA is going to implement consistency within MSHA Nationally. MSHA is going to come up with a draft for Instructor approval. NCMAQB would have to go by the Southeast MSHA requirements. William – It would be great that MSHA is getting the entire Country on board with the same training requirements.

Reporting Accidents

One fatal accident was reported to MSHA. An employee of a company was operating a haul truck. The employee was on the right side of the road and went left going downhill at a high rate of speed and ended up in a 201 feet pit under the carriage of the haul truck. An autopsy was completed and no pre-existing or existing medical issues were found. MSHA is doing the investigation and during the investigation they found that the employee had rags tied on other seatbelts. MSHA issued a citation to the company for knowingly and willingly altering seatbelts. MSHA did not cite the company for the employee not using a seatbelt, but did issue a penalty for the employee using a nonfunctional seatbelt. William – This is the 1st fatality in NC in 4 years. Phil – Did MSHA issue penalties yet? William – Not officially yet.
