# **Junior Olympic Success**

During this Olympic year, Byrum Brown, the son of one of our very own employees (Nicole H. Brown, East Compliance Bureau Chief), had a successful Junior Olympic season, which ended July 31. Prior to the start of the track season, Byrum set a personal goal to become the National Champion in the 1500m and to go the USATF Junior Olympics National Championship in all three of his events (1500m, 800m and turbo-javelin).

When Byrum began the track season, he knew he had a lot of work to do to become a National Champion and to make it to USATF Junior Olympic National Championships in all three of his events. He worked with his coaches at Carolina Elite, as well as his personal running coach, to develop a training regimen that prepared him for each and every track meet. Byrum finished first place in all three of his events in both the State Junior Olympics Championships in Greensboro (NC A&T State University) and the Regional Junior Olympic Championships in Landover, Maryland (PG Sports & Learning Complex). Based on his success at the local and regional level, he earned a chance to compete in the USATF Junior Olympic National Championships that were held at Sacramento State University in Sacramento, California.

The National Junior Olympic Championships has some of the top athletes in the country competing in all track and field events. The top eight athletes in each event earn All-American honors and the first place winner is the National Champion.

While in Sacramento, Byrum finished every one of his events with a personal best in times/distances. Byrum finished in the top three in the nation in all of his events this year.

• 1st place—1500M (4:41.28)—All-American & National Champion

- 2nd place—Turbo-Javelin (43.81m)—All-American
- 3rd place—800m (2:13.47)—All-American

Byrum is not only a good athlete, he is also a good student. Byrum achieved his personal goal to become a USATF Junior Olympic National Champion, but most importantly he maintained all A's for the entire 2015-2016 school year. He also received, the highest score possible (a 5 rating) on all of his 6th grade End of Grade (EOG) testing. Although he is only 11, his work ethic is admirable and he is very goal driven student athlete with big aspirations. He would like to compete in college athletics and maybe even the 2024 Olympics.
